Where the applicant(s) is/are employed. Letter from employer, specifying the applicant's professional status, length of service and gross annual income, together with a copy of the 3 most recent salary slips.

- Copy of the last year's income tax declaration. ( P60)
- Where the applicant's is/are self-employed . Photocopies of the last 3 year' balance sheets and profit and loss accounts, signed by a certified accountant, or other formal proof of income.
